



# Authorised Inspection Scheme Fees

## Purpose

Transport for NSW (TfNSW) has the responsibility for establishing and maintaining fees, charges and penalties administered by Roads and Maritime Services.

In accordance with previous years, TfNSW seeks to apply an inflation factor, validated by the NSW Treasury, based on the annual average movement of the Sydney Consumer Price Index (CPI) of 1.91 per cent from 1 July 2016. The Minister for Roads, Maritime and Freight has approved these CPI adjustments.

The purpose of this notice is to:

- Provide replacement pages for Appendix 1-F of the Rules for Authorised Inspection Scheme (AIS) Stations
- Advise the revised maximum fees for Authorised Inspection Scheme inspections.

The attached revised Appendix 1-F is for all stations. The current Appendix 1-F contained in any printed copies of Rules for Authorised Inspection Scheme Stations must be removed and replaced with the attached.

The revised fees commence on 1 July 2016.
