

# Application for Transfer / Refund of NSW Registrations for Motor Dealers

- Motor Dealers can use this form to transfer or transfer and refund a NSW registration. • You must transfer the vehicle it into your name within **7 days** of it coming into your possession or management.
- If any details are incorrect or illegible Roads and Maritime Services will return this form to you for correction.
- The following must be presented with this form:
  - The certificate of registration (if available)
  - If you wish to cancel a NSW registration you must surrender the number plates or provide a 'surrender number plates' receipt from an interstate authority. **Note:** If the number plates are not surrendered, or are reported lost, stolen or destroyed you will need to complete a Number Plates and/or Cancellation of Registration form (form no 1038).
  - Interstate dealers must also provide their Interstate motor dealer's licence and Dealer Services Officer – Authorisation form (form 1388). **Note:** Not required if already established on the Roads and Maritime system.
