Vehicle Safety Compliance Certification Scheme J&P (VSCCS J&P)

Who should use this form

This form is to be used by VSCCS J&P Licensed Certifiers or applicants for a VSCCS J&P Licence who wish to self-certify.

What is self-certifying?

Self-certifying means that the Licensed Certifier is permitted to inspect and issue a VSCCS J&P Certificate for vehicle modifications conducted by themselves or their own business.

A Licensed Certifier may not self-certify unless formal application (using this form) has been made and approval has been granted by Roads and Maritime Services (Roads and Maritime).

Roads and Maritime will allow self-certification only in cases where appropriate systems and processes are in place to ensure that the assessment of the vehicle modification against the applicable vehicle standards is conducted in an objective and substantiated manner that ensures due process in the inspection and certification process.

Licensed Certifiers need to be aware that where approval for self-certification has been granted, they may be subject to an audit by Roads and Maritime to confirm that the appropriate systems and processes are in place and applied.
