Environmental Impact Statement

The Environmental Impact Statement (EIS) for the Hornsby Quarry Road Construction Spoil Management project is on public exhibition for community comment until 4 September 2015.

The EIS outlines the key features of the project and assesses the potential environmental and social impacts of the project. It also outlines measures to minimise and manage these impacts.

The project is being assessed as State Significant Infrastructure under Part 5.1 of the *Environmental Planning and Assessment Act 1979*.

Tips for writing a submission

There is no right or wrong way to make a submission and all submissions received will be considered by Roads and Maritime. Your submission can be as short or as long as you like. Some suggestions for writing a submission include:

- Type your submission
- Use double spacing
- Use page numbering
- Use headings
- Clearly identify any issues or concerns you have with the proposal and provide any suggestions that you may have to address your concerns
- If you have more than 5 pages, include a content list and brief summary
- If you are representing an organisation, state this clearly, include your affiliation and statement of relevant authorisation
- Always keep a copy of your submission.

Next steps

Roads and Maritime will consider all submissions received and provide responses to issues raised in a submissions report. This may include a preferred infrastructure report, if changes to the project are required as a result of submissions received.

When the submissions report is complete, Roads and Maritime will send out letters to acknowledge your submission was received and guide you to where in the document you can find responses to your issues raised. Please be advised that you will not receive an acknowledgment letter from Roads and Maritime if you have chosen to remain anonymous. However, you can confirm we received your submission with DPE.

This submissions report will be published on the website and submitted to DPE for determination by the NSW Minister for Planning. If approved, the project would be carried out in accordance with any conditions of approval.
