



## Parking arrangements at Skyline Shops, Frenchs Forest Road East, Frenchs Forest

Roads and Maritime Services is planning changes to the intersection of Frenchs Forest Road East with Allambie Road and Patanga Road as part of the Northern Beaches Hospital Stage 1 Connectivity Work. This proposal would alter the current parking arrangements at the Skyline Shops.

Roads and Maritime is proposing to relocate the existing parking spaces outside the Skyline Shops as part of the proposed Stage 1 Connectivity Work. The proposed changes to the parking are required to allow widening of Frenchs Forest Road. Twenty new parking spaces will be provided on Frenchs Forest Road East to ensure customers and local business operators can access Skyline Shops.

The location of the proposed parking spaces and the parking restrictions include:

- 20 x two hour 90 degree parking spaces along the southern side of Frenchs Forest Road East between Allambie Road and Warringah Road – confirmation of the timed parking restrictions is subject to Warringah Council approval
- 1 x unrestricted parallel disabled parking space
- 1 x unrestricted parallel loading bay.

Parallel parking will remain on Patanga Road and will start 20 metres back from the stop line of the proposed new intersection with traffic lights to be installed as part of the Northern Beaches Hospital Stage 1 Connectivity Work.

We have provided a diagram to help better explain the proposed parking changes at Skyline Shops.



Proposed parking arrangements at Skyline Shops, Frenchs Forest Road East, Frenchs Forest



## Background

The NSW Government is planning to upgrade roads around the new Northern Beaches Hospital with work planned to be completed in time for the hospital opening. These upgrades would provide customers with a better travel experience by car or bus, increase the capacity of the road network and improve access through the area, including for pedestrians and cyclists.

Roads and Maritime is planning to deliver the road upgrades in two stages:

- Stage 1 Connectivity Work would provide essential access to the Northern Beaches Hospital
- Stage 2 Network Enhancement Work would help increase capacity of the road network and reduce congestion.

Both stages of the project will be assessed in accordance with Part 5.1 of the *Environmental Planning and Assessment Act 1979*.

The Environmental Impact Statement (EIS) for the Concept Proposal and Stage 1 of the road upgrade project was displayed in late 2014 for community comment.

At the time the EIS for Stage 1 was displayed, the parking arrangements at the Skyline Shops were still being investigated. Roads and Maritime has completed further design work and traffic modelling. As a result, Roads and Maritime is now proposing 20 new parking spaces to replace the existing parking in front of the Skyline Shops.

Roads and Maritime is preparing a separate EIS for the proposed Stage 2 road upgrades and expects to display the EIS for comment by mid-2015. The EIS for Stage 2 will outline the key features of the network enhancement proposal and the potential environmental, social and economic impacts of the proposal during construction and operation. It will also outline measures to manage and reduce the identified impacts.

Roads and Maritime has consulted extensively on the project since March 2014. We thank the community for ongoing involvement and feedback.
