

Project update - Intersection improvements on Parramatta Road, Five Dock

The NSW Government is funding this proposal as part of its \$225 million Pinch Point Program which aims to reduce delays, manage congestion and improve travel time on Sydney's main roads.

Roads and Maritime Services invited feedback in December 2016 on the Review of Environmental Factors for a proposal to provide an additional westbound right turn lane from Parramatta Road into Great North Road to improve traffic efficiency at the intersection.

We received comments from one person requesting further improvements to the proposal.

After considering all comments, along with the proposal's aims and design requirements, we have decided to proceed with the proposal unchanged. We have responded directly to questions or concerns raised and thank everyone for considering the proposal and for their feedback.

What happens next?

We will proceed with the detailed design of this project. This work is scheduled to start in 2018.

We will provide the community and stakeholders with the opportunity to comment on the construction schedule at a later date.


The work will include:

- providing an additional right turn lane from Parramatta Road into Great North Road to increase capacity and stop queuing into the through traffic lanes
- widening Parramatta Road on the northern side and Great North Road on the eastern side to accommodate the additional right turn lane
- widening the bridge over Iron Cove Creek to accommodate the additional right turn lane
- realigning the footpath on Parramatta Road and Great North Road
- upgrading traffic lights and drainage
- relocating utilities and services
- removing around 40 metres of parking space on Great North Road. This will be changed to a "No Stopping" zone
- removing and replacing asphalt and painting line marking
- landscaping.
