Traffic changes and road closures on Tukara Road and Jamison Road, South Penrith from Friday 14 February 2020

The Australian and NSW Governments are jointly funding this work as part of the \$1.6 billion upgrade of The Northern Road between Narellan and South Penrith.

Transport for NSW is continuing work along The Northern Road between Glenmore Park and South Penrith. We are now getting this section of the road ready to open in late 2020. As part of this work, we need to install utilities along The Northern Road at Tukara Road and Jamison Road.

Upcoming work and road closures

For this work, we will need to partially close Tukara Road, South Penrith for a period of **five weeks** commencing **Friday 14 February 2020**. To minimise impact on road users, we will have one lane open at all times. We will carry out this work at night, for **three nights a week** during the closure period. We may also work during day shifts.



Our night work hours will be from:

- **9pm to 5am Monday to Thursday**
- **9pm to 8am Friday and Saturday**
- **9pm to 5am Sunday.**

Our day shifts will be from:

- **7am to 6pm Monday to Sunday.**

Detours will be in place via Maxwell Street and Fragar Road to access The Northern Road and Tukara Road.

Property access for residents along Tukara Road will not be affected. However, there may be limited street parking during this period.

There will be no access to Tukara Road via The Northern Road during this time.



We will also need to temporarily close Jamison Road on **Friday 14, Saturday 15 and Monday 16 February 2020**.

Our night work hours will be from:

- **9pm to 8am Saturday**
- **9pm to 5am Sunday**
- **9pm to 5am Monday**

Access to Jamison Road and the Northern Road will be in place via Smith Street and Fragar Road, and via Stafford Street and Bringelly Road.

There will be no access to the Eastern and Western side of Jamison Road via The Northern Road during this time.

How will the work affect you?

During our work, you may experience some noise and extra light and every effort will be made to minimise the impacts by:

- using non-tonal reversing beepers on machinery
- turning off equipment and vehicles when not in use
- using lighting towers only when necessary
- directing noise generating equipment away from resident properties where possible.

Plant and equipment

The project team will use heavy and light vehicles, lighting towers, and power and hand tools.

Traffic control and electronic message signs will be in place to direct road users through these changes.
